VFW Launches PACT Act Referral Tool

Last month, VFW Adjutant General Dan West announced the deployment of a new webpage designed to inform veterans about benefits for which they may qualify due to the PACT Act and to generate referrals to their local VFW accredited service officer. Starting Wednesday, Nov. 16, veterans may now navigate to https://pactactinfo.org where they can enter certain military service details and medical conditions to help determine if they are eligible for compensation benefits on a presumptive basis as a result of exposure to toxins while serving in the military.

Retirees Get a Second Chance to Enroll In or Opt Out of the Survivor Benefit Plan December 22, 2022

Military retirees who opted out of a valuable survivor's benefit when they left active duty will get a rare second chance to enroll thanks to a new rule in the 2023 National Defense Authorization Act. The same measure allows currently enrolled users to leave the program.

Retirees typically get only one chance to enroll in the Survivor Benefit Plan (SBP). Those who opt in usually name their spouses as the beneficiaries, said Mark Belinsky, director of currently serving/retired affairs for the Military Officers Association of America and an Army retiree.

The SBP is like a life insurance policy with no cap. After a retiree dies, the SBP pays a beneficiary up to 55% of the retiree's retirement pay, adjusted for inflation, monthly for the rest of the surviving spouse's life, or till a child reaches an age cap.

The SBP is such "a very good plan," Belinsky said, that for retiring service members to opt out, their spouses have to consent.

But despite the benefit's high face value, many retirees declined coverage because of a rule known colloquially as the "widow's tax" and officially as the Survivor Benefit Plan offset. That law reduced SBP payments to spouses who were also eligible for the Department of Veterans Affairs' Dependency and Indemnity Compensation (DIC) allowances. DIC allowances are for the surviving spouses of service members who died on active duty or of veterans who died from injuries received as a result of their service.

The Defense Department has eliminated the SBP offset in phases, with full removal as of the Feb. 1, 2023 pay date, so now is a good time to open up enrollment, Belinsky said.

When service members decline coverage at retirement, a few life changes allow them to enroll. For example, if a service member was single at retirement and later gained a spouse. But limitations apply. Those who opt in -- the default -- get to withdraw or change their coverage only in their third year of receiving retirement pay or in limited other situations such as if their beneficiary dies first.

A child may also receive the benefit, but not for life, as may others such as a business partner or parent in the absence of a spouse or children.

Those who enroll during the open season will have to catch up on paying the premiums they missed since retiring plus pay interest and "any additional amount" deemed necessary to maintain the "soundness" of the Defense Department's retirement fund, according to the new law.

Current enrollees can opt out during the open season with their spouse and/or beneficiaries' consent but won't receive a refund for the premiums they've already paid.



The open season to enroll begins with Biden's signature and ends Jan. 1, 2024. Anyone receiving retirement pay who hasn't already enrolled in the SBP may take advantage of the open season in 2023. Retirees are eligible who either already receive retirement pay or who would receive it except they haven't yet reached age 60.

HOT OFF THE PRESS

For 60 Years, the Navy Has Been Training Dolphins and Sea Lions to Keep Rivals Away From Its Most Sensitive Hardware

Since 1959, the U.S. Navy has trained a small force of bottlenose dolphins and sea lions to recover lost equipment, intercept intruders in ports, and detect buried sea mines.

This year, the Navy sought to end one of those marine mammals' most important missions — hunting for and neutralizing mines buried in the seabed — and use sophisticated underwater vehicles and sensors instead. But there's a problem: That technology hasn't yet equaled a dolphin's unique ability to find mines. So Congress balked, using the 2023 defense bill to bar the Navy from retiring its mine-detecting dolphins or ending port-security training for its marine mammals until it deploys new minecountermeasure systems that are as good or better. Congress' move halts the long-planned retirement of Marine Mammal Systems, a program run by Naval Information Warfare Center-Pacific at Point Loma Naval Base in San Diego. The proliferation of highquality, relatively inexpensive drones means that the Navv's dolphins and sea lions may soon be deactivated, but for now they remain a part of the service's minecountermeasures systems, alongside ships, helicopters, sonars, and mobile explosive ordnance disposal (EOD) teams.

THIS MONTH IN HISTORY

January 20, 1649 - At the conclusion of the English Civil War, King Charles I was brought before a high court of justice at Westminster Hall on charges of treason. The Civil War had been fought over whether the King's power was absolute or was limited by the powers of Parliament. Oliver Cromwell had led the Parliamentary forces to victory over the Royals. In the trial that followed, Charles was found guilty and condemned as "a tyrant, traitor, murderer, and public enemy" and was beheaded several days later in front of Whitehall Palace in London.

January 21, 1793 - In the aftermath of the French Revolution, King Louis XVI of France was guillotined on the charge of conspiring with foreign countries for the invasion of France. During the Revolution, the King had attempted to flee to Austria for assistance. Ten months later, his wife, Queen Marie Antoinette, was also guillotined.


